REGULATIONS FOR STAYS WITH ANIMALS

- 1. Permission for an animal to stay at FOUR WINDS RESORT & SPA is issued by the reception if the animal meets the requirements of the regulations.
- 2. The animal must have its own bedding and it is forbidden for the animal to sleep or use bedding or upholstered furniture. For sleeping in bedding or use of upholstered furniture, an additional fee of 150 PLN will be charged.
- 3. There is an additional fee associated with the stay of a pet in the hotel.
- 4. Only pets (dogs and cats) are allowed on the premises.
- 5. The condition for accepting an animal is prior notification of the arrival of guests with the animal.
- **6.** We accept only healthy and clean animals. The facility has the right to refuse to accept sick or neglected animals.
- 7. On the premises of FOUR WINDS RESORT & SPA and in the surroundings of the facility, animals must be walked on a leash and muzzled (in the case of dogs), under the care of the owner or an authorized person.
- 8. The stay of a pet in the Four Winds restaurant is possible. We reserve the right to refuse a dog in the restaurant if the dog will interfere with the comfort of the stay or threaten the safety of other guests. If the animal reacts nervously to the presence of other animals, barks or howls we refuse to accept it in the restaurant.
- **9.** During your stay in the restaurant, the owner is obliged to ensure that the presence of the animal is not a nuisance to other guests and the restaurant staff. Please take a seat and do not walk around the restaurant hall with your pet.
- 10. The owner is responsible for the behavior of the animal in the facility, keeping it quiet and not disturbing other Guests. In the event of repeated complaints from other Guests, FOUR WINDS RESORT & SPA reserves the right to request that the pet be removed from the facility.
- 11. Any damage to the property of the Facility or to the property of other Guests caused by the animal will be individually assessed by the Directorate and the cost will be charged to the Owner of the animal.
- 12. The owner is obliged to clean up the waste left by the animal on the premises and in the surroundings of the facility. Dog owners are asked to take their pets outside the premises, and cat owners must have a litter box with sand. In case of non-compliance with this point, the hotel reserves the right to charge an additional fee for extra cleaning of the waste left by the animal. The fee is 50 PLN for each action taken by the facility.
- 13. No animal should be left alone in a room if it disturbs other guests at the time.
- **14**. We only accept neutered cats.
- **15.** The facility has the right to refuse animals that are generally considered threatening or aggressive, including spiders and reptiles.
- **16**. We reserve the right not to accept or revoke permission for the animal to stay at the facility In case of aggressive behavior towards people, small children and other animals staying at the hotel.
- 17. Dear visitor, when walking in the forest with your dog (Vistula Spit Landscape Park), please to observe the rules in force in forest areas, resulting from the provision of Article 30 paragraph 1 point 13 of the Act of 28.09.1991. Remember! Letting a dog loose in the forest is punishable by a fine.
